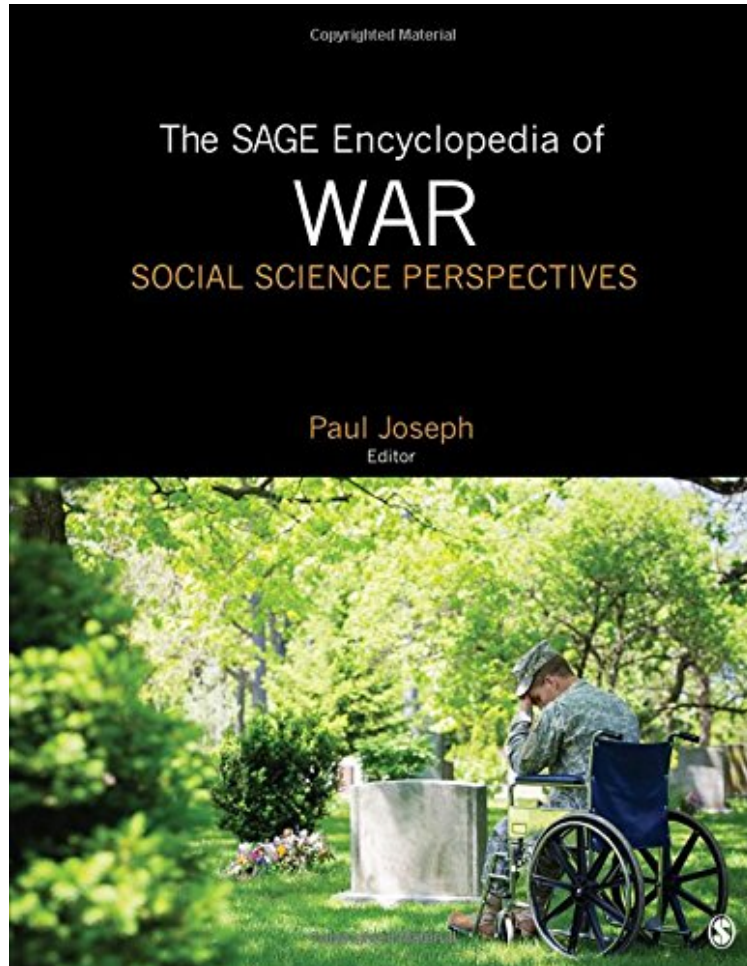

He received his BA from McGill University and his MA and PhD from the University of California, Berkeley. His research specialty is military policies: how they are shaped by economic, political, and organizational interests and influenced by public opinion and peace movements. His books include a decision-making study of the Vietnam War; a review of the debate over nuclear policy; and an analysis of the security implications of the end of the Cold War. Recent titles include *Are Americans Becoming More Peaceful?*, which explores the influence of public sensitivities toward war given the George W. Bush administrations management of Operation Iraqi Freedom, and *Soft Counterinsurgency*, an examination of "human terrain teams," the social scientists who were embedded in combat brigades in Iraq and Afghanistan.He has also published articles, review essays, and encyclopedia entries on race and class in the United States, on Maori-Pakeha (European) relations in New Zealand, on the memory politics surrounding Hiroshima and Nagasaki, and on the influence of peace movements on government policies.
